

**Procedure and method for the registration of attendance of an electronic meeting  
 (e-AGM), appointment of proxy, voting and vote counting**

---

**Procedures for Attending the Shareholders' Meeting Electronic means (e-AGM)**

Shareholders or Proxies who wish to attend the meeting must submit the following identification documents to the company by 5:00 p.m. on April 24, 2026. Once the company has verified the information against the list of shareholders entitled to attend the meeting as of the record date, the e-meeting service provider will send a meeting Link and user manual to the email address you provided to the company. The link will be sent one day before the meeting (April 27, 2026).

**Notice of Intention to Attend the Electronic Meeting**

A shareholder who wishes to attend the electronic meeting must notify their intention to attend in two ways:

1. Notification of Intention to Attend the Meeting Website or QR Code.
2. Notification of Intention to Attend the Meeting E-mail or Postage.

**(1) For shareholders who wish to attend the electronic meeting (e-AGM) by Website or QR code.**

2. Fill in the shareholder's information.
  1. Securities account number.
  2. First name (without title).
  3. Last name.
  4. National ID number.
  5. Accept the terms and conditions and consent to the access of personal data.
  6. Click "Confirm".
3. Verify the shareholder's name and number of shares.
  1. Full name (in English).
  2. E-mail address to receive the meeting Link.

3. Mobile phone number.

For shareholders attending the meeting in person: please provide your mobile phone number.

For shareholders attending the meeting by proxy: please provide the **mobile phone number** of the proxy holder. This number will be used to access the meeting.

4. Select the type of meeting participation.
  - i. Attend the e-AGM meeting in person.
  - ii. Grant a proxy to a general person to attend the e-AGM meeting.
  - iii. Grant a proxy to an independent director.
5. Click "Next".

**For shareholders attending the meeting in person.**

Please prepare the following documents to verify your identity:

1. A Copy of the ID card, passport, or identification card issued by the government.
2. Other documents, such as a company certificate of incorporation.
3. Click "Next".
4. The system will display the message "Information received successfully." Please verify your name, surname, and number of shares again.
5. Close the window to complete the process of submitting your intention to attend the meeting.

**For shareholders grant a proxy to a general person to attend the e-AGM meeting.**

Prepare the attached documents to confirm the identity of the shareholder:

1. A copy of the ID card, passport, or identification card issued by the government.
2. Other documents, such as a company certificate of incorporation.
3. Click "Next".
4. Enter the proxy's information and attach supporting documents.
  - i. Full name of the proxy (Thai)
  - ii. Full name of the proxy (English)
  - iii. Attach a copy of the proxy's ID document.
  - iv. Attach the completed and signed proxy form.
5. Click "Next".
6. The system will display the message "Information received successfully." Please verify your name, surname, and number of shares again.
7. Close the window to complete the process of submitting your intention to attend the meeting.

**For shareholders grant a proxy to the independent director.**

1. Prepare supporting documents to verify your identity. (The same documents are required for shareholders attending the meeting in person).
2. Attach the completed proxy form with your signature.
3. Click "Next".

4. The system will display the message "Information received successfully." Please verify your name, surname, and number of shares again.
5. Close the window to complete the process of submitting your intention to attend the meeting.

Remark: The system for submitting intentions to attend the meeting will be open from April 10, 2026 to April 24, 2026 (The system will not be available on Saturdays, Sundays, and public holidays).

**(2) For shareholders who wish to attend the electronic meeting (e-AGM) by E-mail or Postage.**

1. Please fill out the e-AGM Attendance Intention Form (Enclosure 1). Please clearly indicate your email address and mobile phone number for registration.
2. Attach a copy of your identification document to verify your right to participate in the e-AGM meeting.

2.1 Individual shareholders

- For shareholders who attend the meeting in person, electronic means (E-Meeting)
  - A copy of the identification card issued by the government, such as a national ID card, government ID card, driver's license, or passport. If your name has changed, please attach additional supporting documents.
- For shareholders who grant a proxy to a general person to attend the meeting by electronic means (E-Meeting)
  - A proxy form, as attached to the meeting invitation, is filled out completely and signed by both the shareholder and the proxy. The proxy form must be stamped.
  - A copy of the shareholder's ID, such as a copy of their national ID card, government ID card, or passport (for foreigners), signed by the shareholder and certified true copy.
  - A copy of the proxy's ID, such as a copy of their national ID card, government ID card, or passport (for foreigners), signed by the shareholder and certified true copy.

2.2 Juristic Shareholders

- For juristic shareholders (directors) who attend the meeting in person, electronic means (E-Meeting).
  - A copy of the juristic shareholders' certificate of incorporation. Issued no more than 1 year before the shareholders' meeting date. Certified as a true copy by juristic shareholders (directors) who are authorized to sign.
  - A copy of the juristic shareholders' identification document, such as a copy of their national ID card, government ID card, or passport (for foreigners), is not expired and certified true copy.
- For juristic shareholders (directors) who grant a proxy to attend the meeting by electronic means (E-Meeting).

- Proxy form, as attached with the meeting invitation, Fill in the information correctly and completely. and signed by both the shareholder and the proxy. The proxy form must be stamped duty.
- A copy of the juristic shareholders' certificate of incorporation. Issued no more than 1 year before the shareholders' meeting date. Certified as a true copy by juristic shareholders (directors) who are authorized to sign.
- A copy of the juristic shareholders' identification document, such as a copy of their national ID card, government ID card, or passport (for foreigners) is not expired and certified true copy.
- A copy of the proxy identification document, the same as in the case of individual shareholders as mentioned above.

In case the aforementioned documents or evidence are not in Thai or English, the shareholder must submit an English translation of the document certified by the person authorized to sign it to bind that juristic person (in the case of juristic shareholders).



3. Submit a request document to attend the meeting in electronic means (paragraph 1) and proof of identity along with supporting documents (paragraph 2) to the company by **April 24, 2026** before 5:00 p.m.

#### Attending the Electronic Meeting (e-AGM).

1. Once shareholders or proxies registered to attend the meeting have been verified, you will receive an E-mail from the meeting organizer. This E-mail will contain a Link to join the meeting and a user guide one day before the meeting date. Please read the user manual carefully before the meeting. If you have not received the E-mail by April 27, 2026, please contact the company immediately.
2. Preparing your information to log in to the system  
For shareholders attending the meeting in person: shareholder account number (securities holder registration number) and ID card number.  
For proxy holders: the proxy holder's ID card number and mobile phone number.
3. Joining the meeting and voting can using a computer, laptop, tablet, or mobile phone through the Chrome web browser. you will need a 4G internet connection or home broadband internet.

Remark: In case joining with a tablet or mobile phone and need to install the Zoom Cloud Meeting app before, You can download the app here:

4. The system will open for participants to join the meeting 60 minutes before the meeting starts. However, the live broadcast will only start at the meeting time.
5. To log in, participants must use their shareholder registration number and ID card number.
6. Voting through the E-Voting system, you will be able to vote on each agenda item by voting either "Agree", "Disagree", or "Abstain". In case you do not vote on any agenda item, the system will automatically count your vote as "Agree" (using the "count all abstentions as votes in favor" method).
7. In case of any problems or difficulties using the e-AGM system, participants can contact OJ International Co., Ltd. at the phone number provided in the E-mail with the system user manual.

**For shareholders who cannot attend the e-AGM in person**

For shareholders who are unable to attend the e-AGM in person or unable to grant proxy to another proxy to attend the e-AGM, if shareholders wish to grant proxy to an independent director, please send a proxy form (Enclosures 7) specifying the independent director to whom you wish to grant proxy as determined by the company, along with supporting documents, to the company by 5:00 p.m. on April 24, 2026.

Note: If the shareholders specify their votes in each agenda, the independent directors will cast their votes as specified in the proxy form. In which the voting in each agenda, shareholders have the right to vote in agreeing, disagreeing, or abstaining only and cannot divide a partial vote (unless it is a Custodian vote).

For a shareholder who is a foreign investor and appoints a custodian in Thailand to be the depositary and caretaker of the shares. Please submit the following information.

1. Proxy Form C (attached with the meeting invitation) Fill out the form completely and correctly. Sign by both shareholder and proxy. Affix a 20 Baht stamp.
2. Certificate of Incorporation of the Custodian and Certified True Copy by an authorized signatory of the Custodian. Affix the company seal (if any).
3. Power of attorney from shareholder to custodian, authorizing the custodian to sign the proxy form on behalf of the shareholder.
4. Confirmation Letter, confirming that the signatory of the proxy form is authorized to conduct custodian business.
5. Copy of ID Card, Government Official ID, or Passport (for foreigners), of the proxy recipient, certified true copy.

#### **Guidelines for Vote Casting, Vote Counting and Announcement of Voting Results**

##### **Guidelines for vote casting**

##### **General agenda:**

1. One share shall be entitled to one vote. Shareholder or proxy shall cast only one vote for approval, disapproval or abstention, and cannot split votes in each agenda item (except voting of the Custodian).
2. In case of proxy:
  - 2.1 The proxy shall vote in accordance with the determination given by the shareholder as specified in the Proxy Form. Any vote not in accordance with the Proxy Form is deemed to be invalid and shall not be counted as the vote of the shareholder.
  - 2.2 In case the shareholder does not specify the determination, or the determination is unclear, or the Meeting considers or resolves any agenda other than that specified in the Proxy Form, or there is any change or increment of fact, the proxy shall be authorized to consider and vote on such matter as he or she deems appropriate.

##### **Agenda on Election of Directors:**

Agenda for the election directors, the shareholder or proxy shall have one vote for one share and shall cast the vote individually.

##### **Voting procedures**

The Chairman or a person assigned by the Chairman shall inform the Meeting the details of voting procedures as follows:

1. The Chairman or a person assigned by the Chairman shall propose the Meeting to vote in each agenda by asking the meeting whether there is any shareholder or proxy who approves, disapproves or abstains from voting.
2. For each agenda, shareholders or proxies who disapprove or abstain from voting shall press the “disapprove” or “abstain” buttons as shown on the screen, while shareholders or proxies who approve are not required to press any buttons. The rest of the shareholders who do not vote “disapprove” or “abstain” shall be considered as votes of approval. Shareholder or proxies shall vote only in one manner, except for the vote of Custodian, who may split their votes as specified in the Proxy Form.

**Resolution of the meeting shall comprise of votes as follows:**

1. **General case:** the resolution shall be passed by a simple majority vote of the shareholders present at the meeting and cast their votes.
2. **In other case** in which the law or the Company’s Articles of Association stipulated otherwise: the resolution shall conform to the law or the Company’s Articles of Association which the Chairman shall inform the Meeting before voting in each agenda.

A shareholder who has any special interest in any agenda cannot vote on such agenda. A shareholder having special interest or proxy of such agenda, such shareholder may be invited by the Chairman to temporarily leave the meeting.

**Counting and notification of the voting results**

Prior to the Meeting, the Chairman or a person assigned by the Chairman shall inform the vote counting procedure to the Meeting before the consideration of the first agenda. The Company shall conduct the vote counting in each agenda from the votes of shareholder or proxy presented at the Meeting. The vote result of every agenda shall be informed to the Meeting before the Meeting is adjourned.

**Submission of Recommendations or Questions Related to the Agenda for Consideration at the e-AGM Meeting.**

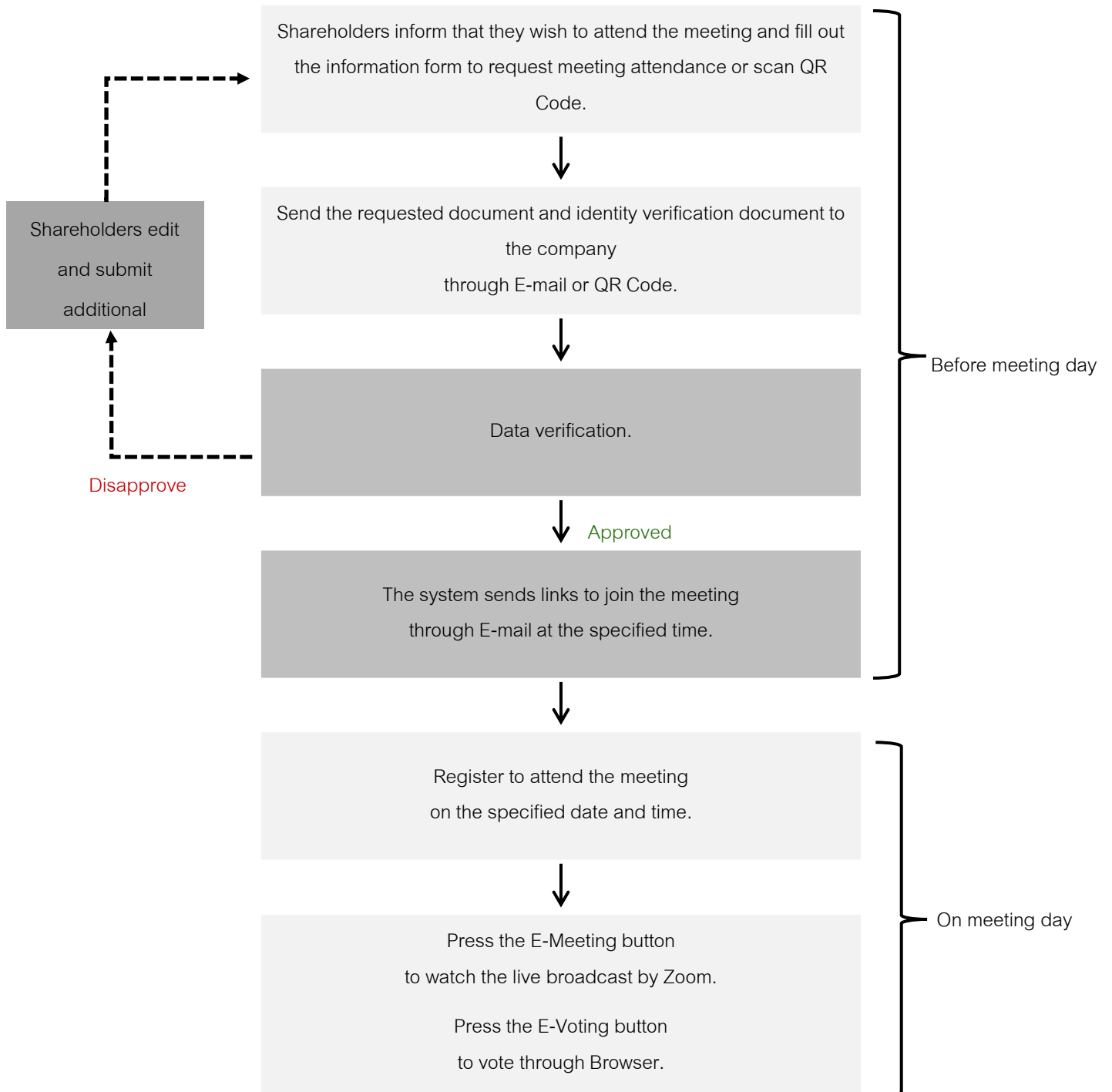
In case shareholders wish to submit recommendations or questions, can do so in 2 ways

1. Submitting recommendations or questions in advance to the Company before the meeting date sent to E-mail : corporate@zalekta.com
2. Submitting recommendations or questions during the meeting, those participating in the e-AGM meeting must identify themselves by stating their full name along with informing them that they were the shareholders attending the meeting themselves or as a proxy before submitting recommendations or questions. Participants can submit through the chat function only.
